**RALEIGH, NC** – The Collie Health Foundation has continued its dedication to funding canine health studies by their recent generous contribution of \$50,000. **Performance Summary:** The purpose of this study is to study hypothyroidism in dogs. This is a very common hormonal abnormality in dogs which may cause hair loss and skin infections. In humans, serum levels of the pituitary hormone thyrotropin (TSH) has been used as a detector of thyroid glandular insufficiencies. However, this detector has not been useful for dogs. Therefore, this study searches to improve the current and future immunoassay sensitivity based upon a pure recombinant canine TSH hormone standard by expressing and purifying recombinant canine TSH in high quantities and validate its use.

The investigator has successfully completed the genetic phase of the project and has been able to produce reasonable quantities of high purity of canine TSH *in vitro*. The investigator was not able to establish stable cell lines expressing cTSH, but the transient transfections of cells using the PEAK method has been able to generate sufficient quantity of cTSH protein devoid of contaminating LH and FSH. The study showed the need to remove LH and FSH during protein purification in order to obtain a sensitive enough antibody for cTSH. Unfortunately, the investigator was not able to generate an anti-cTSH monoclonal or polyclonal antibody that is able to be used in a canine TSH assay widespread.

At the completion of the study, a more sensitive assay for detecting cTSH levels has not been developed but cTSH was purified using a recombinant DNA which is better quality than previously used cTSH for antibody generation and standards.

**Objectives completed:** Completed. 8/10 complete and 2/10 deferred with previous approval.

Planned Publications—”Expression and purification of recombinant canine TSH and its standardization for diagnostic immunoassay”, to submit to *Veterinary Clinical Pathology*.

**Significant Accomplishments:** High quality cTSH was produced from recombinant DNA and purified. This DNA can be used for cTSH standards and development of a more sensitive cTSH measurement assay.

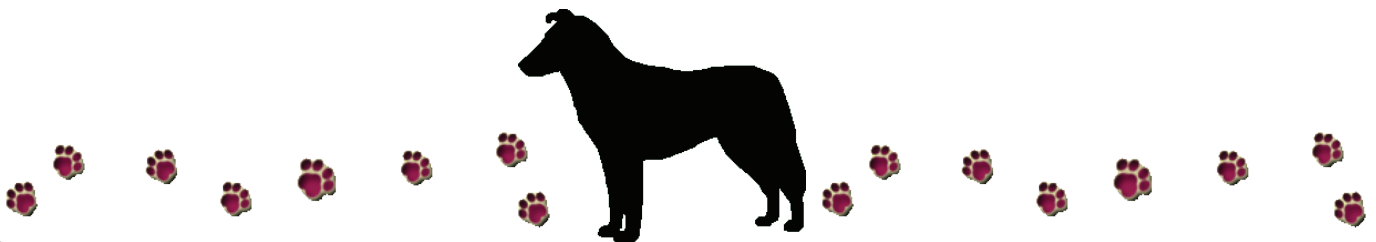
